MBAE ACHIEVES CRITICAL VICTORY ON COMMON CORE: CLEARS PATH FOR CAMPAIGN TO LIFT CAP ON CHARTER SCHOOLS On July 1, the Massachusetts Supreme Judicial Court dealt a major victory to students and teachers when it issued a ruling that the initiative petition to repeal the Common Core State Standards did not meet legal requirements to go on the November ballot.

The decision was the culmination of an effort led by the **Massachusetts Business Alliance for Education**, with financial support from donors including members of **Boston Leaders for Education**, to protect high academic standards that focus on college and career readiness. The ballot measure would have set students back, created significant costs for the state as well as cash-strapped cities and towns, and politicized the process by which we decide what kids learn.

The SJC victory also benefits the campaign to lift the cap on charter school enrollment in Massachusetts. Two education-related ballot questions – one urging a Yes vote and the other a No vote – would compete for limited resources and risk confusing voters. Removing the common core question from the ballot clears a path for the charter school campaign.

MBAE Board of Directors Chairman Bill Walczak was one of ten plaintiffs who appealed the Attorney General's certification of the common core ballot measure, along with **Springfield Business Leaders for Education** member Jack Dill, teachers, principals, superintendents, parents, and former members of the Board of

The Boston Blobe Common Core supporters win key victory with SJC ruling

The state's highest court dealt a critical blow Friday to an effort to scrap the state's adoption of the Common Core classroom standards, striking down a proposed November ballot question.

Education. MBAE is grateful to all of the plaintiffs, and particularly appreciates the active advocacy of Stephanie Gray, the President of the **Massachusetts Parent Teacher Association**, and Bob Antonucci, the former Commissioner of Education and president of Fitchburg State University.

Prior to the SJC appeal, MBAE and the **Massachusetts Association of School Superintendents** submitted a memorandum to the Attorney General opposing certification on the grounds that it failed to meet the technical and constitutional requirements for placement on the ballot. That effort was made possible with pro bono legal support from **Foley Hoag LLP**, which also represented the plaintiffs in the appeal. MEASURING WHAT STUDENTS REALLY NEED TO KNOW: MBAE ADVANCES HIGH QUALITY ASSESSMENTS Representing employers' view that too much time is being spent on standardized tests that set too low a bar, MBAE led the call over the past year and a half to replace MCAS with new high quality assessments that measure students' ability to think critically and problem solve rather than simply memorize.

MBAE's report comparing MCAS and PARCC, the assessment that was piloted in Massachusetts, showed the state's 18-year-old MCAS doesn't indicate a student's preparedness for post-high school success. Its lack of alignment with college and career expectations has led to nearly 36% of Massachusetts public high school graduates who enroll in state colleges and universities being placed into one or more noncredit-bearing, remedial courses. The report was instrumental in shifting the debate from *if* Massachusetts should adopt a new test to *what* the new test should look like.

MBAE led a coalition with key partners **Stand for**

Children and **Teach Plus Massachusetts** that beat back efforts to stay with the old MCAS. Our thoughtful, evidence-based positions

helped earn positive editorials from *The Boston Globe* and other leading Massachusetts newspapers. Our position that Massachusetts needs assessments that give teachers, students and families information about whether students are on track and how to help get or keep them there was consistently represented in news stories including in one on the front page of *The New York Times*.

The Board of Elementary and Secondary Education voted in the fall to develop MCAS 2.0, a next generation assessment that is based on PARCC and that sets a higher bar for teaching and learning.

OTHER RECENT MBAE ACCOMPLISHMENTS


Represented employers as a voting member on the **Foundation Budget Review Commission**, a high profile legislative commission examining school funding. MBAE advanced the goal of transparency in school funding and fought proposals for spending without assurance that aid would be spent on effective instruction for students it is intended to benefit.

Future Ready Massachusetts, an initiative that provides tools and resources to get more students ready for college and career, increased its impact significantly over the past year.
